WHEREAS, Wednesdays have created conflicts with other meetings, including meetings related to City Government; and

WHEREAS, the Council desires to change their Council meetings to Tuesdays in order to avoid those conflicts;

NOW THEREFORE, be it ordained and enacted by the Spanish Fork City Council as follows:

SECTION I

Section 2.08.030 of the Spanish Fork Municipal Code is hereby amended to read as follows:

2.08.030 Council-Regular meetings.

The City Council shall conduct three regular meetings, each month, which shall be held on the first, second, and third Tuesday of the month, at the Spanish Fork City building, 40 South Main, which meetings shall begin promptly at 7:00 p.m. If the meeting day is on a legal holiday, then the meeting shall be held at the place described in this section at a date and time established by the Council. The Council shall conform to the state open meeting law in rescheduling meetings continued in conflict with a legal holiday.

SECTION II

This Ordinance shall become effective immediately upon passage.






