ORDINANCE 04-98

AN ORDINANCE CLARIFYING THE CRIMINAL PROVISION OF THE SEWER REGULATIONS

WHEREAS, Spanish Fork City maintains the publicly owned treatment works commonly know as the Sewer Treatment Plant Facilities; and

WHEREAS, the State of Utah regulates and monitors the Sewer Treatment Facilities; and

WHEREAS, as part of the State regulation and oversight, penalties are required against persons who violate the provision of the law; and

WHEREAS, the State of Utah has reviewed and approved the Spanish Fork City Ordinance currently in place, but has approved a section on criminal prosecution which should be clarified; and

WHEREAS, it is in the best interest of the City and its residents to treat sewage in an efficient and sanitary manner, thus protecting the environment and the health and safety of its residents;

NOW THEREFORE, be it ordained and enacted by the Spanish Fork City Council as follows:

Section I.

Section 13.32.690 Spanish Fork City Municipal Code is hereby amended to read as follows:

13.32.690 Criminal Prosecution

A. Any person who willfully or negligently violates any provision of this chapter (13.32.010 et seq.), or any person who orders or permits others to do so, shall be guilty of a Class B Misdemeanor.

B. Each day that such condition continues shall be a separate offense.

Section II.

This Ordinance shall become effective 20 days after passage and publication.


