ORDINANCE 09-98

AN ORDINANCE MAKING AMENDMENTS TO THE CAPITAL FACILITIES PLAN ELEMENT OF THE GENERAL PLAN

WHEREAS, Spanish Fork City has adopted a comprehensive general plan which includes as an element thereof a capital facilities plan; and

WHEREAS, a capital facilities plan need to be amended from time to time in order to assure adequate capital facilities and infrastructure are in place and planned for the growth of the City; and

WHEREAS, amendments to the capital plan have been prepared an submitted to the Planning Commission which held a public hearing thereon on the 1st day of July, 1998; and

WHEREAS, a public hearing was held before the Spanish Fork City Council on the 7th day of July, 1998 wherein public impute was received; and

WHEREAS, in order to protect the health, safety, and welfare of the residents of the City, it is necessary to update the capital facilities plan and keep it current;

NOW THEREFORE, be it ordained and enacted by the Spanish Fork City Council as follows:

Section I.

The Capital Facilities Plan Element of the Comprehensive General Plan is hereby amended as shown on the addendum attached hereto.

Section II.

This Ordinance shall not be part of the Spanish Fork City Municipal Code.

Section III.




