ORDINANCE NO. 07-02

ORDINANCE AMENDING THE MUNICIPAL CODE

CONCERNING COUNCIL MEETINGS

WHEREAS, the Spanish Fork Council has been meeting three times a month; and

WHEREAS, the third meeting has been a work meeting, which has required little time in recent months, therefore making it desirable for the council to meet twice each month; and

WHEREAS, the work of the council can be more efficiently performed by meeting twice monthly until the work load increases;

NOW THEREFORE, be it ordained and enacted by the Spanish Fork City Council as follows:


1. Section 2.08.030 of the Spanish Fork City Municipal Code is hereby amended to read

as follows:

The City Council shall conduct two regular meetings each month, which shall be held on the first and third Tuesdays, at the Spanish Fork City Office Building, 40 South Main, which meeting shall begin promptly at 6:00 p.m. If a meeting is scheduled on a legal holiday, then the meeting may be held at the city office building at another date and time established by the council. The council shall conform to the state open meeting law in rescheduling meetings continued in conflict with a legal holiday.

2. This ordinance shall become effective January 1, 2003.






