### RESOLUTION 02-04

**A RESOLUTION AUTHORIZING THE USE OF SPANISH FORK CITY'S  
2002 ALLOCATION OF HOME FUNDS AND COMMUNITY HOUSING  
DEVELOPMENT ORGANIZATION FUNDS TO ASSIST IN THE DEVELOPMENT OF  
AFFORDABLE HOUSING PROJECTS LOCATED IN UTAH COUNTY**

WHEREAS, The Utah Valley Consortium of Cities and County ("UVCCC") receives an annual formula allocation of HOME funds from the Department of Housing and Urban Development for the purpose of addressing homelessness and expanding the supply of affordable housing, and

WHEREAS, UVCCC receives an annual allocation of Community Housing Development Organization (CHDO) funds for the purpose of addressing homelessness and expanding the supply of affordable housing, and


WHEREAS, Spanish Fork City is a member of the UVCCC and is eligible to receive as its share of 2002 HOME funds the sum of \$83,025.95, and as its share of CHDO funds the sum of \$16,605.19; and

WHEREAS, HOME funds from each member of the UVCCC will be needed to cover the costs of all proposed projects.

NOW, THEREFORE, be it resolved that the Spanish Fork City Council authorizes Spanish Fork City's share of the 2001 HOME funds in the amount of \$83,025.95, and its share of CHDO funds the sum of \$16,605.95 used in the development of any of the following project(s):


- *Rural Housing*
